DUTIES OF PARKS AND RECREATION COMMISSION

Under Chino Hills Municipal Code, Chapter 2.32, the Parks and Recreation Commission shall advise the City Council on all matters subject to the jurisdiction of the City Council pertaining to:

- Acquisition, development and maintenance of public parks, recreational facilities and open space.
- Financing of and budgeting of such functions, including, but not limited to the financing and budgeting for park and recreation services in the City.
- Trail development, maintenance and expansion.
- Coordination and development of organized sports.
- Wildlife preservation.
- Coordination with the State Parks Department.
- Other matters assigned by the City Council.

DUTIES OF PLANNING COMMISSION

The duties of the Planning Commission shall be those described by the Government Code of the State of California (Section 65100 et seq.) and Chino Hills Municipal Code, Chapter 2.36. The Commission shall act as custodian of the visual character of the City and shall also have the following functions:

- Planning for the physical development of the City.
- Carry out the precepts and intent of the City's Zoning Ordinance.
- Review and approve, conditionally approve or deny tentative subdivision maps.
- Make recommendations to the City Council for the establishment of appropriate zoning boundaries for new annexations to the City.
- Review the General Plan and make a report thereon annually to the City Council.
- Periodically review the Zoning Map and the text and the Zoning Ordinance and make recommendations to the City Council for change.
- Periodically review the Subdivision Ordinance and make recommendations to the City Council for amendments or additions.

DUTIES OF PUBLIC WORKS COMMISSION

Under Chino Hills Municipal Code, Chapter 2.40, the Public Works Commission shall have the general power and duty to act in an advisory capacity to the City Council. The Public Works Commission shall advise the City Council on:

- Public Utility matters including electric, telephone, and gas companies community service levels.
- Cable television issues impacting the City including public access channels and channel programming requests.
- Waste management, recycling programs, and hazardous waste disposal
- Water and sewerage improvement projects.
- Rate structure and sewerage levels for water and sewerage
- Promote development and use of reclaimed water.
- Hold public hearings as deemed necessary.
- Perform other related duties or studies as directed by the City Council.
- Traffic Safety--Provide a means of improving traffic and safety to include, but not be limited to, stop signs, traffic signals, speed limits, crosswalks, bicycle routes, parking control, bus and truck routes, and related matters.
