Inclement Weather: Attempts will be made to reschedule any games cancelled due to inclement weather. If games cannot be rescheduled, a \$4 registration credit will be issued to each individual player.

Coed League Forfeits: A team unable to play must notify the Grand Avenue Park sports office by 10 a.m. the day before the scheduled game. If a team does not inform City staff of their forfeit by the deadline, the team will be charged the forfeit fee for the number of officials assigned to their game. Forfeit fees must be paid prior to the start of their next scheduled game.

Men's League Forfeits: A team unable to play must notify the Grand Avenue Park sports office by 5 p.m. the Friday before the scheduled game. If a team does not inform City staff of their forfeit by the deadline, the team will be charged the forfeit fee for the number of officials assigned to their game.
