

NEW REGULATION PROHIBITS **ELECTRIC BICYCLES AND MOTORIZED SCOOTERS ON PUBLIC SIDEWALKS**



This new ordinance is designed to enhance safety by adding public sidewalks to the list of restricted areas for e-bikes and motorized scooters, which already includes City-owned open spaces, City trails, and City Parks. The City partners with the Chino Hills Police Department to enforce these regulations. Failure to abide by the Chino Hills Municipal Code (CHMC) or the California Vehicle Code (CVC) may result in significant fines and towing.
