- ♦ Parade kick-off at 7:00 p.m.
- Parade route details will be provided to participants upon approval of their application.

Entry Requirements

- ♦ Trailer/Boat: Boats must be 32' or less in length and 13' or less in height at the highest point. Sail boat masts must be down.
- Jet Skis & Personal Watercraft: Jet skis and similar personal watercraft are not permitted. Other types of trailers may be allowed with prior approval. Please contact us in advance for authorization of any trailer you plan to bring.

Registration

- Registration opens on Tuesday October 21, and closes on Wednesday, November 26.
- Complete and return the application, announcer script information, participation agreement, Chino Hills release waiver and provide a current copy of the tow vehicle insurance card.

- Participants will receive an email confirmation once all required registration materials have been submitted.
- At check-in, participants will be issued printed numbers which will be gently affixed to their entry vehicles. These numbers assist with vehicle identification by parade announcers, City Staff, and law enforcement during the parade.

	Boats must be decorated with lights. Power generation is the responsibility of the owner.		
	Decoration of the towing vehicle is optional at the owner's discretion.		
	No items (candy, glow sticks, etc.) shall be thrown from boats or tow vehicles. Parade participants ar welcome to walk alongside boats and lightly toss items into the crowd.		
	No confetti shall be thrown by parade participants.		
	No Santa Claus costumes allowed.
